## **COPYRIGHT LICENSE**

Please sign both copies, retain one for your files and return the other to the editorial office.

Nonexclusive Publication Agreement

Agreement: We look forward to publishing your Article in a forthcoming issue of African Arts. You will retain the copyright to your Article since this agreement does not transfer copyright. For the protection of your work, we require that an author whose work is to appear in African Arts give the Regents of the University of California and its representative, African Arts, as well as its distributor, the Massachusetts Institute of Technology Press (MIT Press), a nonexclusive license, including the exclusive right of first publication in English, prior to publication of the Article in African Arts.

Rights Reserved by Author: By retaining the copyright to your Article, you are reserving for yourself the following rights among others: 1.) to photocopy the Article for use in your own teaching or research activities, and 2.) to publish the Article or permit it to be published by other publishers subject to certain anthology and periodical rights given to MIT in the following paragraph. Since, with the exception of first publication rights, the licenses we require are nonexclusive, they do not prevent you, the author, from giving or selling similar licenses such as abstracting, indexing, translation, reprinting, educational photocopying, electronic reproduction/distribution, and document delivery rights to other publishers. You promise to make future publishing agreements involving the Article contingent on the appropriate first publication credit being given to African Arts.

<u>Licenses to UCLA:</u> You hereby grant to the Regents of UC a nonexclusive license to copy, distribute, display, perform, create derivative works of, and publish the Article in <u>African Arts</u> in both print and electronic formats, and to publish reprints of the Article in its context within the <u>African Arts</u> issue, and in anthologies derived from <u>African Arts</u> and as part of such license you give us the exclusive right of first publication in English. This license explicitly includes the right to sublicense the rights granted to our distributor, MIT Press.

Note that <u>African Arts</u> and its contents are distributed on behalf of UCLA and the Regents of UC by MIT Press in various ways. MIT Press has standing agreements with educational photocopying, microfilm and abstracting/indexing services which reach many people and institutions that do not necessarily subscribe to <u>African Arts</u>. Some of these agreements also encompass document delivery, the electronic reproduction and distribution of journal Articles, and links to online copies of journal Articles by encyclopedias.

All Articles published in <u>African Arts</u> are included in these agreements, which allow them to reach a larger audience. The nonexclusive license you grant to African Arts to publish your Article includes worldwide permission for us to do the following: to permit others to make photocopies of the Article for classroom use only, to permit others to create abstracts of the Article, and to permit secondary publishers to reproduce the Article in microform or any

computer-readable form, including electronic on-line databases and document delivery systems. These licenses will endure for the entire term of copyright in the Article in all media.

Warranties: You warrant that the Article has not been previously published anywhere in English, that you are the sole author(s) of the Article, and generally that you have a complete and unencumbered right to make the grants you make to us, including the use in the Article of all photographic material submitted by you with your text. You also warrant that the Article does not libel anyone, violate any rights of privacy, or publicity, or invade anyone's copyright or otherwise violate any statutory or common law right to anyone. You agree to hold harmless and indemnify the Regents against any claim, demand, suit, action, proceeding, recovery or expense of any nature whatsoever arising from any claim of infringement of copyrights or proprietary rights based upon or arising out of any matter or thing contained in the Article.

<u>In Conclusion:</u> This is the entire agreement between us, and it may be modified only in writing. It will bind and benefit our respective successors in interest, including assignees, and our licensees, provided that you may not assign this Agreement without our prior written consent. It will terminate if we do not publish your Article within two years of the date of your signature(s).
