

LICENSE AGREEMENT - CONTRIBUTION TO COMPUTER MUSIC JOURNAL SOUND AND VIDEO ANTHOLOGY

We look forward to including your audio or video (“the Work”) tentatively entitled

in a compilation that we intend to publish containing the Work and other material (“the Compilation”), entitled “Computer Music Journal Sound and Video Anthology”, that is to be published in conjunction with Computer Music Journal Volume ____, Issue ____ (COMJ ____). You will have already furnished to the Compilation’s Curator (“the Curator”), _____, a high-quality digital file containing the Work. If you are sending us an audio or video recording of a musical and/or artistic creation, the “Work” will be deemed to include the particular recording that you are supplying to us as well as the underlying composition.

You hereby grant to the Massachusetts Institute of Technology (MIT), a non-exclusive, royalty-free, world-wide license (i) to reproduce and distribute the Work as part of the Compilation and other Computer Music Journal collections, (ii) to license transmission of the Work in all media and post excerpts of the Work on the Internet, in connection with promoting such collective works; (iii) to permit the Work to be included in any database in which Computer Music Journal is included; (iv) to license or sublicense others to do any of the above; and (v) to make a digital file of the Work available for download, listening and viewing via the MIT Press web page that is devoted to contents of Computer Music Journal. You understand that all revenues from the exercise of these licenses will be retained by MIT.

Although you are delivering the Work to the Curator in digital form, the licenses you have given MIT here include all other forms and formats as well. While the Compilation will be copyrighted in Massachusetts Institute of Technology’s name as a collective work, you will retain the copyright and all other rights in the Work, subject only to the licenses stated above.

You warrant that you are the sole author(s) of the Work, that you have full, unfettered rights in it and that it is an original work that does not infringe on any copyright. If persons other than you have contributed to the performance or recording of the Work, you warrant that the performance was recorded with their consent, with full knowledge that it would be published by you or under your authority, that you own all rights in the recording, and that no persons under the age of majority participated in the performance. If there is more than one author of the Work, and not all of them are signing this license agreement, you warrant that you are authorized to sign for all authors. You warrant that no author of the Work is a member of the Screenwriter’s Guild, and that no author or performer has any rights to compensation with respect to the Work under any collective bargaining agreement. If the Work or any part of it has been previously published or contains material copyrighted by a third party, you further warrant that you have obtained all necessary permissions or licenses and are enclosing them with this form. You agree to indemnify us against any claim or action alleging facts that, if true, constitute a breach of any of these warranties. Your indemnity will cover our losses, legal fees and expenses, as well as any damages, profits or settlement amounts we may pay.

This agreement will be governed by U.S. copyright laws and the contract laws of Massachusetts. It will be binding on and inure to the benefit of our respective successors, assigns, licensees and sub-licensees. It may not be amended except in writing.

If the above is agreeable to you for the Work, please sign and date this agreement and return it to the Computer Music Journal Editors or MIT Press Subsidiary Rights Manager. Please keep a copy for your records. Upon request, we will send you a countersigned copy in acknowledgment that this is an agreement binding on all parties.

FILE SIZE REQUIREMENTS - PLEASE CHECK ONE: For most browsers, there is a file size download limit of 2 gigabytes. In addition to this limit, if your file is larger than 300 megabytes, **then we will need an additional version that is 300mb or smaller to post in addition to your preferred file. We ask that you either A:** provide this 300mb or smaller file yourselves, **or B:** grant MITP permission to create a smaller, compressed version of your original file.
